Course Officer's Report

Firstly, I would like to start by thanking all involved in the successful application for the Sports Capital grant. We were awarded €46,000 to cover the sanding of the fairways, which should help with the drainage of the course.

The first number of months of the year were extremely wet, with persistent rain from November to May, so little or no golf was played.

Eoghan Buckley, our Head Greenkeeper, tendered his resignation in February. Eoghan was with us for three and a half years and made many improvements on the course, while working on a tight budget. I would like to wish him and his family the very best in his new role of head greenkeeper in Birr golf course.

In February Tony Murphy passed away. He was a great servant of the club and had done much voluntary work on the course over the years.

In March our volunteer Martin O'Gorman died suddenly, a great lover of all things GAA, he entertained us on many Thursday's with his stories and love of Clare GAA and no job phased him. He was much loved and sadly missed by those who knew him.

In April Peter Byrne joined us as head greenkeeper having previously worked in Woodenbridge GC. Our course suffered due to the bad weather, but Peter set about getting our course back to the standard we had come to expect. He and his course staff John Fitzgerald, Mark Dowling, John Gleeson and seasonal staff Cian O'Connell and Damien Lyons have worked diligently on the course over the summer, with many improvements being added. I would like to thank them for all their hard work, the condition of the course has been complimented by both members and visitors alike.

The course committee decided that we should get John Cagney in to clean some of the dykes on the course, so that we can monitor how well the drains are working. We also asked him to remove the ditch on the driving range, which should help with the drying of the range and has improved the appearance of the course.

The greens were pencil tined on a number of occasions during the year and hollow tined in early September, which should help with the aeration of the greens and better root growth, leading to faster greens.

In early September, we purchased a scarifier and scarified all the fairways, which should help our drainage with the removal of the thatch, this had to be done before we commenced the sanding.

Nick Greene was contracted to do the sanding, so half the allotted sand was spread on the fairways and then a shockwave machine was used to aerate the fairways and the sand was brushed in. Next Spring we plan to spread the remainder of the sand again on the fairways, but on two half spreadings, a few weeks apart so it won't impact as much on the playability of the course.

During the dry spell we got to see the outline of the drains on the course, so we photographed and got aerial footage of the drain profile of all the holes which is recorded for future reference on a map of the course.

There are a few people I would like to thank namely, Conor Lane for using his drone to record aerial footage of the drains, Greg Collins for outlining the route of the irrigation system and of the drains on the course and Gay McEvoy who was responsible for our compliance and deliverance of the sanding programme.

Many thanks to the course committee Peter Byrne, Jim Crowley, Mark Collins, Siobhan O'Kelly, John O'Keeffe and Jerry Murray for their help and support.

Huge thanks to our Thursday volunteers, John Chawke, Jim Crowley, Jim Harmon, Gay McEvoy, Jerry Murray, John O'Keeffe Paddy O'Kelly, Pat O'Shea and Willie Burke, whose work is much appreciated.

A special mention to Danny Collins for his continued work of removing the daisies from the greens. Thanks to Donal Mc Sweeney and DJ Hourigan who helped with the hollow tining and to Trevor Barry for work done. Also, thanks to Catriona and the staff of Nora May's for catering for us during the year and Trish and Angela for all their help to myself and Peter.

The club needs to put a Capital Investment Programme in place to replace some of our machinery. Our mowers are over 10 years old and can't have many years left and spare parts are getting harder to source.

Going forward a tree planting programme needs implementing and the ponds on the 9^{th} & 16^{th} need to be modified.

Our aim is to continue to improve our course, so that it is enjoyable to play for both members and visitors alike, which in turn should help to generate more revenue for the club.

Finally, it was a pleasure to work with the outgoing officers and I would like to wish our incoming officers, President Barra and Captains Mary and Ollie and all our members a very Happy Christmas and all the best for 2019.

Treasurer's Report

Summary

Hello everyone, it is with some pleasure I present this year's accounts. For the 2017 / 2018 year we targeted a number of costs which were putting a huge strain on the finances. As you can see from the accounts we achieved a significant reduction on the costs. This had to be a big part of managing this year especially following on from the sale of land last year and clearing the long-term bank debt. The income area which I will discuss in full took a severe battering due to the adverse weather conditions from October to May, hence the positive effect of the costs being so important. We completed the year with a positive income over expenditure of €32,227.

Income

Our membership was €211,000 for the year, a reduction on previous year by €13,000. Significant here was the number of members that did not renew either through travel or through the adverse weather conditions. Our members at the end of the year totalled 457 a reduction of 17 on the previous year. The income categories all suffered due to the adverse weather conditions Green fees, Men's Club and Ladies club combined €16,000 adverse on 2017. In our other items, our fundraising including donations was back €11,500 with the Lotto favourable €1,000 and we had €9,500 gain on exceptional items giving an income of €16,800 for 2018.

Expenditure

We have 3 cost categories, in House expenses we spent €34,000 which included repairs to the Annex of €10,500. We had a rearrangement of our house costs billing with Nora May's which reflected in an €8,000 energy reduction in the accounts. On our course expenses we had €12,000 of a saving versus 2017 with the reduction mainly around chemicals, sand and machinery repairs. General expenses were considerably favourable with water and insurance charges €30,000 better than 2017. We also had a reduction in bank interest of €8,000. Total expenditure was €53,000 less than 2017.

Progress

In the year we applied for the Sports Capital Grant and were successful with €46,000 sanding grant. We have applied the first half of that in September and we should see benefits in the winter period. The second half is planned

for March 2019. Also, in this year we resurfaced two-thirds of our car park. This was a significant job and the benefits of this should be around for years to come. Many thanks to the members who supported the golf classic, those who provided monetary assistance in the form of loans and also to the County council for a €10,000 grant.

Appreciation

I would like to thank all the staff for their efforts and commitment to the golf business, Peter and his Greens staff, Trish and Angela, Mark our Professional for his work on our behalf, to all the committees and to the Committee of Management for their hard work and dedication. For the lotto a huge thank you to Tony Connolly and his team, and also to Tony on a personal note for help preparing the accounts. To Gay McEvoy for progressing the sanding grant on our behalf, thank you. Thanks to David A. for keeping the show on the road. A note of sadness this year with the loss of two Trustees of the Club who would have assisted in the financial management, Eily White and Tony Murphy, may they rest in peace. Finally, thanks to you, the members, for backing the Club. There have been some fairly dark days and only chinks of light, however if we can progress on the road we are on we will hopefully clear ourselves in the coming years.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30th SEPTEMBER 2017

1 Principal Accounting Policies

The financial statements are prepared under the historical cost convention. The currency used in these financial statements is the Euro denoted by the symbol €

Income & Expenditure:

Annual membership fees and levies represent all amounts, in respect of the year, received up to closing of accounts.

Other items of income represent all receipts and amounts due to the Club at the year-end.

Expenditure represents all payments made and all amounts owing by the club at the year-end.

Fixed Assets:

The cost of purchased fixed assets is their net invoiced price together with Installation costs where relevant.

Proceeds of Land Sales less Book Value are transferred to Capital Reserve.

Depreciation:

Depreciation is provided at the following annual rates in order to write off the asset over its useful life.

Lands	Nil
Buildings and Course Development	5%
Machinery	10% – 20%
Fixtures & fittings	15% – 20%
Computer equipment	25%

Sanding, drainage and other course improvements are written off in the year in which they occur.

Asset Sales:

The proceeds of Land Sales in excess of the net book value is credited to the Capital Reserve.

Stocks:

Stocks are valued at the lower of cost and the net realisable value.
